- 1. Abstract Submission Deadline Friday, May 10<sup>th</sup>, 2024, at 11:59 PM (EST)
- 2. Abstract Notification Presenters will be notified via email of abstract status on Friday, May 31st, 2024.
- 3. Presenters may not use any conference presentation to market products or services; exhibit tables are available for purchase for that purpose.
- 4. If accepted, presenters must register for the conference and pay the appropriate registration fee. In addition, no honoraria or travel expense reimbursement will be provided for any presenter submitting through the call for presentations.
- 5. For oral presentations, the standard audio/visual equipment provided by FPHA includes a projector and screen, podium microphone and laptop with internet connected and audio to run a PowerPoint presentation. TVs, phone lines, or other equipment will **NOT** be provided. If needed, it will be the responsibility of the presenter(s) to make arrangements and provide payment for such equipment. Presenters must also bring a back- up copy of his/her presentation on a flash drive.
- 6. Oral presentation sessions are 60 minutes in length including questions and answers. Presentations with an interactive component are highly encouraged. For example: panel, role playing, polling, group discussion, small table talk, etc.
- 7. Poster presenters will present during allotted breakout times over the course of one of the 2 days, you will be assigned your designated day prior to the conference. For each day, 20 poster presenters will be selected for a total of 40 for the entirety of the conference.
- 8. FPHA will work to obtain continuing education for licensed healthcare professionals for all eligible sessions. Accepted oral presenters will be asked to provide objectives, citations, bio through the application process. The speaker agrees to provide FPHA an electronic version of the presentation in either Microsoft PowerPoint or Adobe PDF version by Monday, July 22<sup>nd</sup>, 2024.
- 9. Presentations not submitted through this form will not be considered.
